Some students are achieving the higher grade bands. However, there is a noted increase in failing students in cohort 14. Within the higher grade students, there is a good depth of knowledge being shown.

Some students appear to struggle with the Applied Science modules and this year was no exception with the performance of some first year students proving to be weaker than we would have hoped for. There is no clear justification for this, although a review of student engagement revealed that only a minority number of students made use of the available support services and revision materials. Only three students attended the revision day which was held prior to the re-assessments. Student performance, together with a review of the programme's entry requirements, will continue to be monitored. Students will also continue to be made aware of the support services available and sign posted to these at all available opportunities.
