# 2.2 Quality of candidates' knowledge and skills, with particular reference to those at the top, middle or bottom of the range

The range of marks is consistent with past years. There were some exceptional results amongst the higher range candidates who demonstrated excellent knowledge and reflective writing skills. Most candidates appeared to benefit from the formative feedback showing improved scores whatever the starting point skill level. A few candidates struggled to adapt to the reflective writing required for this module, despite the advice and feedback provided. Encouragement is given to these candidattes to use the 1-2-1 coaching sessions available.

# 2.3 Please provide any additional comments and recommendations regarding the students' performance

For the students who have to resubmit essays consistent feedback is the lack of reflective writing. Follow up advice is detailed with good signposting to resources, however a small number of students still struggle to adopt reflection into their submissions.

A bank of 'before and after' examples of short pieces of text rewritten into a reflective style might support students new to this style of writing early on with their studies.

Assessment methods and detailed formative feedback are appropriate in helping students towards the course aim of improving through reflection.

To ensure the AFAVP module retains relevance to students and adequately prepares them for subsequent modules and careers the AFAVP module is under review. The number, titles and grouping of essays is being considered alongside assessor allocation. Learning through reflection will remain a central feature of the RVC Cert AVP approach as does ongoing support for student progression.

#### 3.4 Standard of marking

Facilitiated by the use of templates, essay marking and feedback has become more detailed with advice on how to access appropriate resources and improve future submissions. This has received good student feedback.

Yes. The procedures for assessment and the determination of awards are sound and fair. Sufficient information is provided at all stages of the process. The Board of Examiners meeting is well attended with broad participation.

#### 3.6 Opinion on changes to the assessment procedures from previous years in which you have examined

Essays and assessment reports are now online. The time taken to mark essays has been reduced from 8 to 4 weeks which has addressed negative student feedback in the module survey report. Could the RVC note over time whether this improved marking turnaround has any impact on student motivation, length of time taken to complete modules and student retention for further modules?

We will certainly endeavour to although the factors influencing student motivation and feedback for a totally "distant" course such as the CertAVP are multifactorial. We are instituting several initiatives to help with student engagement at a distance and to prepare candidates for this type of academic endeavour so if there is an improvement in completion rates it may be hard to tease out what elements have had the most impact.
