1.1 Course content

This is the first run through of the new curriculum. Having also been external examiner for the course previously we can see where tracking across has been done with great care and we are satisfied it covers the necessary information. We were able to blueprint across the entire course to compare contents of the course against assessed learning objectives. The course is comprehensive.

In broad terms, this course aims to provide clinical integration of basic science concepts for students with a previous science based undergraduate degree. This is achieved through a modular structure that includes the following modules:

- Animal form and function
- Infectious and responses
- Animal husbandry (including animal handling)
- · Principles of veterinary practice
- Integrated and applied anatomy

Thank you, it is gratifying to hear that the transition from the previous curriculum to the new curriculum has been smooth and that alignment of learning outcomes to course content continues to be mapped comprehensively and clearly.

In addition to several curriculum changes that have taken place at module and unit level, this year has seen the introduction of the Animal Handling DOPS assessments and a more fully expanded Principles of Veterinary Practice module (formerly Professional Studies) with compulsory formative reflective assets contributing to this cohort's assessment and progression requirements. Integrated and Applied Anatomy small group sessions (formerly ISF tutorials) continue to contribute a valuable element of applied teaching incorporating the use of our live animals. While not specifically considered a module, these sessions link neatly with several PAFF units and integrate basic sciences teaching and anatomy in the applied clinical and live animal context.
