## **Duration of the Degree**

The FdSc Veterinary Nursing degree programme takes three years. It also includes a minimum of 1,800 hours of placement. These placements are compulsory and may involve additional travel costs. Please see further information under 'Fees and Costs'.

## **Methods of Teaching**

Teaching is delivered by a blend of online and face to face lectures, seminars, group activities, recorded videos, practical sessions and placements. Students will be expected to undertake various self-directed activities and additional study to complement the taught content. For the duration of the course, you will be in the same cohort as the BSc VetNursing students. At the end of your third year of study, you will graduate with an FdSc and be registered with the Royal College of Veterinary Surgeons as a Registered Veterinary Nurse. Upon successful completion of the FdSc you will have an opportunity to join the fourth year of the BSc course, subject to you fulfilling set academic requirements.

The Royal Veterinary College awards the degree, and the RCVS accredits the FdSc awarded after year three to ensure it meets the requirements to enter the official RVCS register.

Students undertaking the FdSc Veterinary Nursing degree programme are taught at the RVC's clinical campus near Potters Bar in Hertfordshire. However, it may be necessary to visit the Camden campus or RVC farm on occasion and students will normally be expected to make their own travel arrangements and incur any costs.

# **Fees and Costs**

The fee for UK students studying undergraduate degrees at RVC in 2023-24 is £9,250 per annum.

The fee for EU and other international students studying undergraduate veterinary nursing degrees at the RVC in 2023-24 is £17,550 *per annum* (please see below for policy on subsequent years).

## Tuition fees in future years

It is RVC policy to set and review tuition fees on an annual basis. The fees indicated above are for the first year of tuition only and may be subject to increase in future years (see below). Should it be necessary to increase these costs, you will be consulted, and notice given as to when such increases may occur and by how much.

# **Explanation of Fees**

The RVC adheres to the UK Government's legislation regarding fees for UK students which sets the maximum fee for these categories. Subject to the approval of legislation in parliament in future years, institutions including the RVC may be permitted to raise fees for UK students at an inflationary rate linked to the Retail Price Index (RPI). Therefore, we, advise all UK students considering studying at the RVC to plan their finances based on yearly inflation increases.

The fees for EU and international students are also listed at the above links. These are substantially higher than UK fees as the RVC receives no government subsidy or support for such students and therefore must charge "full cost fees". In deciding the annual level of increase for EU and international students, the RVC will consider a range of factors, including rises in the costs of delivering its teaching and changes in government funding. The increase will not exceed 5% each year or the Retail Price Index (RPI), if higher. We will publish the fee in September of the preceding academic year.

## Additional costs

The fees do not cover accommodation costs which, for veterinary nursing students who in 2023-2024 opted to live on campus in College Close, cost £152 per week (2024-25 cost tbc). College Close accommodation does not have a fixed term contract.

Placements are a compulsory part of the degree and students will be required to fund their own transportation (and accommodation where applicable) to placement providers.

As well as accommodation costs and travel to placements, you should also allow approximately £100 for a nursing uniform, £75 for simple equipment such as fob watches etc., and £210 for enrolling with the Royal College of Veterinary Surgeons (RCVS) and approximately £141 to join the RCVS register at the end of year three.

#### **EU students and Brexit**

For EU students accepting a place on a programme for entry in the academic year 2024/25, your fees will now be the same as other international students, as listed above.

EU students are permitted to enter the UK. However, to stay and study for the duration of the course, they will need to apply for immigration permission either through the EU Settlement Scheme or the Student Visa route.
