The Programme

1.1 Course content

Course content is very satisfactory in that it reflects the full range of subject knowledge and skills that should be covered in this/these degree(s) at these levels.

The only issue the externs noted is that while there have been attempts made to diversify the species types utilised in exam questions, a more multi species approach could be further developed for examining. The course/s (and assessments) need to continue to focus in appropriate ratios on the following species: dogs, cats, exotics and horses (and ideally other species) at a 'core level', and dogs, cats and exotics equally at a more advanced level. Some of the exams at times appear very dog and cat centric. For example, the SAQs in the Applied Nursing Care (ANC) module (e.g. first and re-sit exams) had 6 dog Qs and 1 rabbit question. Externs feel there still could be more species variety. Internal examiners tend to use a 'dog' example when any species would sometimes work in a generic question (e.g. skin wound management). As a reflection of this, the students equally appear to largely default to dog and cat examples in the work they do, even when an approach across species is asked for in the assignment guidelines (e.g. the written assignment re: Nursing Models in the ANC module). The final year student projects however, showed a range of interests across species, including both rabbit and wildlife which is encouraging.

2.2 Quality of candidates' knowledge and skills, with particular reference to those at the top, middle or bottom of the range

The knowledge and skills of the average candidate are good. The spread of marks in our opinion does appropriately reflect student ability. Those candidates at the top end of the BSc perform at an exceptionally high level. Some students attempting to move between the FdSc and BSc courses do struggle (half the prospective candidates failed to achieve progression between the courses) but this appears to be a reflection of academic ability rather than teaching.

2.3 Please provide any additional comments and recommendations regarding the students' performance

The external examiners sampled a range of scripts and written assignments and are happy with the marks awarded and standards achieved.

The student blog appears to have been an issue for some students resulting in failing due to incomplete coursework. Consideration needs to be given as to how the students are reminded to complete the blog and of any new or additional time limits placed within the course for blog submission(e.g. before they can sit an exam) rather than the blogs becoming an issue at the end of the course.

In addition, it would be helpful if the NPL permitted students to log the number of actual hours the students complete in practice placement.

With regards to the blogs, students are now advised to submit any outstanding blogs during the reassessment period in a hope that this will ensure students are not failing at examination boards from non-submission. The students are regularly reminded about their blogs by their tutors and the course team with messages going up on Learn.

It would be really useful if students could log their placement hours on NPL as this could be monitored by the College and also by the regulatory body (RCVS) who provide the NPL. The Course Director has been encouraging HE!s to support this. As a team we have noticed improvement on the student's ability with regards to referencing, however some students still struggling with the concepts of researching and citing relevant evidence. The Learning Development team deliver various study skills lectures during the first term for the first years. Unfortunately the student feedback after the module indicated these were unnecessary as the students knew these concepts. It was not until after the assessment that some students realised they needed to have a better understanding of what is required at university level. However, modifications have been introduced to address this and the Learning Development Team continues to provide support in this area throughout the course and we continue to encourage engagement of the students to get the support they need.

Marking is generally very consistent as illustrated in the double marking. This is aided by common grading scheme (CGS) and 10 point marking schemes. Use of sample marking is good and the double marking of re-sits is excellent.

Marking at the top end of the 10 point scale is sometimes a little generous -not many answers, however good are 'perfect' or 'almost perfect' even within the guidance provided with the CGS. This is perhaps one of the few negatives of using the same

common grading schemes at all stages of the course. Differentiation between students however, remained fair and consistent at all times. The 0-10 point marking descriptors are a more holistic in nature depicting how well the student has answered a question rather than collating a number of marks per item of the question. 3.6 Please provide any additional comments and recommendations regarding the assessment process

Care needs to be taken, when choosing the marking scheme to use (CGS vs 10 point scale) as it is important the exam format and the marking scheme 'match' adequately (for example at present in the Research Methods module examination which has 4 separate SAQ-style exam questions, students are being marked holistically by the 17-point CGS which is probably better suited to marking longer written answers or assignment/ project work).

Externals were particularly pleased with the standard of presentations for the final year BSc student projects. There was much evidence of good provision of student supervision and feedback being provided by staff members. Those providing such supervision are to be congratulated for doing so as the evidence is that such provision was of an excellent standard. The quality of presentation was very good overall with appropriate use of visual display. Students appeared competent and confident in presenting, which was lovely to see and a reflection of their obvious good relationships with staff members. The rapport and supportive questioning and comments from the staff in attendance could only have enhanced the student experience in this regard.
