The small number of candidates per module means that it is challenging to maintain a consistent standard from year to year and to avoid drift upwards or downwards. The course management needs to keep a close eye on the consistency between the modules.

There was also a potential problem in that candidates for some modules (C-SAS.1, for example) were submitting a large number of Appendices. Whilst it is suggested that these will not be assessed, the number and content of these appendices could benefit a candidate. Further advice and clarification on what can be included in an Appendix is warranted otherwise this is likely to lead to an upward drift in the number of Appendices submitted.

The issue of consistency between modules is closely scrutinised. All failed work for all modules is double marked and sample marking occurs for about 10% of all submitted C module work. The examiners have been consistent from year to year and where there have been changes in module leader (e.g. C-SAM) the outgoing module leader has worked closely with the incoming leader to ensure consistency of standard.
