HOW YOU CAN FUNDRAISE



SPONSORSHIP WEBSITES

Setting up a page on a fundraising website is quick and easy.

You can set a target, update your progress, and share your page with your friends, family and colleagues. Plus, the money you raise comes to us automatically, so you don't have to worry.

Virgin Money Giving, Just Giving and GoFundMe are popular websites, although we recommend Virgin Money Giving as we receive slightly more of the money raised.

GIFT AID

Everyone who makes a donation or sponsors you, who is also a UK taxpayer, can add Gift Aid to add an extra 25%! Gift Aid does not cost you anything, it just helps us raise more money for animal care.

To claim Gift Aid, we need the donor's full name and home address and postcode. This is used to determine how income tax is being spent and if each donor is eligible, so please check you have this when collecting sponsors on your sponsor form.



SPONSORSHIP AND DONATION FORMS

You can find sponsorship and donation forms at the end of this fundraising pack, and you can also download them on our website.

Make sure you fill in all of your details and the money being raised or donated.



MATCHED FUNDING

Did you know that some employers have set up a scheme where they will match the funds you raise?

This means you can raise up to twice the amount, and help even more animals in our care.

Get in touch with your HR department to find out if they can help you fundraise.

DATA PROTECTION

The law is quite strict on holding other people's information. If you record anyone's information during fundraising, make sure that you destroy any copies and do not keep any personal information after you have finished your fundraising.

BE A SUPERHERO FOR PETS LIKE LEO

Leo came to the Royal Veterinary College with symptoms of vomiting, diarrhoea, lethargy and anorexia, and ended up staying in the Internal Medicine ward for 24 days.

It became clear that nutritional management would play a vital role in Leo's recovery. Leo had a feeding tube surgically placed through the side of his neck into his oesophagus so veterinary nurses could feed and medicate him through the tube directly into his stomach when he did not want to eat. Leo also had a catheter placed in his jugular vein to allow fluids to be administered and blood samples to be taken.

Due to his stomach upset Leo required extra walks each day, followed by a warm bath and the application of barrier creams to help protect the sensitive skin that was hurting him from his persistent intestinal disease.





"The nurses fell in love with Leo. You could always find a member of the team sat in his kennel just chatting to him!"

Leo maintained his loving nature throughout his stay, but as his condition was long term, he sometimes became sad. When the nursing team suspected he might have become depressed, they perked him up with grooming sessions, by moving him to a larger kennel and giving him extra toys to play with.

After further investigations, Leo was treated for Inflammatory Bowel Disease (IBD) and the Internal Medicine nurses spent all day and night with him to provide intensive care, which helped him on his road to recovery. We are very happy that he eventually got to go home with a waggy tail!

HOW CAN THE MONEY YOU RAISE HELP?

We support the Royal Veterinary College's hospitals that see over 25,000 animals a year, by providing them with funds for new equipment and enhanced facilities that enable them to continue their world-class care. We also support clinicians and scientists of the future, as well as the development and application of scientific research.



NEW VET BEDS AND MATTRESSES...

for ongoing care of our dog and cat blood donors who help keep thousands of critically-ill animals alive every year.



PRIVACY SCREENS ON OUR WARDS...

to reduce stress and startling when undergoing procedures such as blood taking, intravenous catheter placement and checking dressings. If cats become startled during these procedures it can be very stressful for them and the staff performing the procedures, so this private examination space is vital.



RIB RETRACTORS...

to assist our world-leading cardiac team when performing heart surgery. The team have seen an increase in demand for heart surgery on smaller dogs, like Chihuahuas, and the smaller size rib retractors are extremely beneficial to those procedures.



EQUINE ELECTROCARDIOGRAM (ECG)...

to improve assessment of horses, matching heart rate to speed and workload. New ECG equipment allows simultaneous recording of heart rate, rhythm, speed and ground inclination giving a much more realistic assessment of their performance than on a treadmill. This will also be used for student research projects including one with the Donkey Sanctuary where 24-hour ECGs in healthy donkeys will be recorded, establishing the number of premature beats expected in healthy animals.

These examples are just an indication of how the money you raise can help. Unless we say otherwise, we do not raise money for specific items. All money raised will go into a central fund that is distributed according to what is needed most at any given time at the RVC.

Whether you like to run, cycle, host an event, jump out of a plane or crawl through the mud, this fundraising pack should help you with ideas on how to get involved, and give you some tips on raising as much money as you can to support the RVC Animal Care Trust. GETTING THE MOST OUT OF YOUR FUNDRAISING

SPREAD THE WORD

Tell your friends, family and colleagues what you are up to and why you are raising money for the Animal Care Trust. You can also put up posters in the offce, and tell your local newspaper.

ASK FOR HELP

We can help you with sponsorship and donation forms. We can also help you with posters, flyers and invitations for your event or challenge. If you ever get stuck, just let us know.

EVENT ESSENTIALS

For some of our team events, we will give you a Team ACT bib or running vest to complete the event in. Email us at act@rvc.ac.uk to see what event essentials are available for your event.

KEEP US UPDATED

Don't forget to let us know how you are getting on. And remember to send some pictures so that we can share your fundraising on social media and our website.

STAY SAFE

Make sure that you and your guests are safe during your fundraising events. If you are taking on a physical challenge, please make sure you are capable of completing the challenge and that you do not take any unnecessary risks.

KEEP IT CLEAN

We're not just talking about making sure your event is family friendly and within the law. Make sure you take some bags with you to clean up the mess after your community dog walk too!



FUNDRAISING GUIDELINES

Fundraising is all about having fun and contributing to causes you believe in, but it's also subject to laws and legislation. Here is some basic, need-to-know information when fundraising:

COLLECTIONS

Collections can be a fantastic way to raise money, but there are strict rules attached. Collections in a publicly owned place must be licensed by your Local Authority (Northern Ireland has slightly different regulations). Before you approach your Local Authority for a license, please advise us of your plans and await approval.

Licenses are not required on privately owned land – just ensure you have the permission of the owner or business. Once you have approval, you'll need to be careful how you approach the public on the day - you must not behave in a way that might cause upset to members of the public when collecting funds.

RAFFLES AND LOTTERIES

Raffles, lotteries and prize draws are all governed by legislation – so before holding one and spending money on getting tickets printed, please contact our fundraising team. Also, be aware that lottery laws cover any events that are purely down to luck or chance, such as duck or balloon races.

INSURANCE

When you organise a fundraising event, you're responsible for making sure it poses no risk to others. That's why we'd recommend you take out public liability cover for events such as a sponsored walk or sports event.

FOOD HYGIENE

Please take great care when handling food and work to basic rules for safe preparation, storage, display and cooking. No one likes a poorly tummy, especially as a reward for raising money for charity.

STORING DATA

Make sure any electronic or paper records you keep about people involved in a fundraising event are destroyed once your event is over. As a rule of thumb, don't keep information about people any longer than you have to, and don't share information or data about someone without their permission.

SUPPORT OUR PIONEERING RESEARCH AIMED AT IMPROVING ANIMAL HEALTH AND CARE

Pet owners can now easily monitor and improve the lives of their pets suffering with diabetes or epilepsy thanks to new apps, funded by donations to the Animal Care Trust and developed by leading Royal Veterinary College veterinary specialists.

The Pet Epilepsy Tracker and Pet Diabetes App allow owners to detail the important factors in the treatment and control of these conditions such as seizure activity for epilepsy or weight and thirst for diabetes. The apps also send helpful medication reminders to owners.

Pet owners can also participate in research that will revolutionise the understanding of these challenging conditions amongst veterinarians and researchers, as well as the way they are treated.

"Thanks to the app I've learned how to identify the types of seizure Billy is having so I can more accurately communicate with his doctors."

Gentle giant Billy, a five-year-old Presa Canario from California, was rescued by his owner Amy at nine-months-old from an abusive breeder who had confined him to a whelping box for the first three months of his life. As a result, he was very shy and somewhat suspicious of other people, but also very sweet.

Billy had his first seizure aged two-and-a-half. Amy began posting about him on social media and connected with Dr. Rowena Packer from the RVC Canine Epilepsy Clinic. That's where Amy learned about the app and she has been using it since then to help manage Billy's condition with great success.

"I benefit from the pill reminder daily and use the seizure log and medicine log as well. These tools have helped enormously during emergency vet trips.

"Knowing that the RVC can download data from my app makes me feel like Billy's disease might help improve protocols for others.

"I have shared the RVC's app with friends and my local veterinary hospital because I think it's a fantastic tool!"
