The BVetMed course at the RVC is reviewed regularly for quality assurance through internal and external mechanisms to ensure that it meets with the standards set out by regulatory and accrediting bodies. The course content for the BVetMed Year 1 which is in its second iteration since the introduction of a new curriculum in 2021/22, is streamlined to provide a systematic flow between subject strands. It provides a hierarchical and integrated learning process; and provides regular week-long breaks within the academic year for reflection and review of taught content. Action Required:

1.3 Teaching methods

Teaching methods, which include didactic lectures (both in person and via recordings), small group teaching, practicals, guided self-directed learning and research projects, appear appropriate. The examiners note, via anecdotal reports from the lecturers, that some students did not take full advantage of the lectures, even when these were available as recordings.

Course Director Response:
The teaching methods employed at the RVC for year 1 teaching comprise of lectures, small group learning, sedirected learning and practicals. Five week-long breaks referred to as 'review and reflect' (R&R) weeks are provided within the teaching calendar and are specifically for the consolidation of learning and with no didactic learning taking place. In-built within the R&R weeks are forms of self assessment that is aligned with the teaching content preceding each R&R week. Students are advised to attend lectures as a part of the teaching and learning process but this is not mandatory. Some students may not attend a lecture or lectures for various reasons but majority of students do attend lectures in person. Lectures are recorded and made available on Learn for students who may wish to revisit the content after the in-person delivery.

2.1 Students' performance in relation to those at a similar stage on comparable courses in other institutions, where this is known to you

The student performance is comparable to what we have observed in other Russell group universities offering similar or related programmes of study (Liverpool, Glasgow, Nottingham). The recent introduction of DOPS into the BVetMed year 1 is welcomed and in line with RCVS requirements.

This is a testament to the high quality assurance standards applied at the RVC in line with the regulatory and accrediting bodies.

2.2 Quality of candidates' knowledge and skills, with particular reference to those at the top, middle or bottom of the range

Overall, the student performance was very good; this cohort of students (>210 individuals) achieved an impressive 22% of distinctions, 17% of merits, while 40% of the students passed the year. Notably, one of the distinction students had reached the BVetMed course via the Gateway course, but there was some concern expressed at the examinations board that this was unusual among the Gateway students, many of whom had performed poorly. Some of the lecturers who had experience of the Gateway students expressed their concern about this outcome, and pointed out that, owing to the COVID pandemic, some of the Gateway students may never have taken a formally invigilated (online or in-person) examination in the past.

It was of interest to note that students who failed to meet the DOPS requirement to progress spanned the full range of performance in the written exam.

One of the external examiners (WVH) had attended the" ISAF Orals", and noted that while some students were extremely knowledgeable and had clearly focused on their studies and revision, a small number had apparently gambled that certain topics might not arise and had ignored them. This issue really stretched the range of marks awarded and, given the enormous diversity of topics that the students might face in the exam, strongly illustrated the discriminatory power of this type of examination. It is, of course, likely that some students are extremely nervous in this situation, but I noted that the internal examiners were at pains to make them relax so that they could cope with the questions.

The performance of the cohort followed a normal distribution pattern with the majority of students lying in the middle (pass) category. The comment regarding student on the Gateway programme as not having had an invigilated exam is perhaps an overriding observation on students who are now in their second year of the BVetMed course. During the formal examination board meeting some staff members expressed suspicions that some students had used artificial intelligence software during their "non-proctored" examinations. This was noted, but it was also noted that would be unlikely to arise again as the 2024 examinations are planned to be held under more formal circumstances.

Course Director Response:
The students read and sign a statement of 'academic honesty and integrity' to abide by the exam regulations governing non-proctored exams. The nature of the non-proctored exam allow students to use all resources available to them including lecture materials, books or online information but with caution on plagiarism. The non-proctored exam in its very nature derives from the student's prior knowledge base and every effort is made to ensure the exam is non-googleable. That notwithstanding, the suspicion that some students used artificial intelligence (AI) to generate answers was raised and subsequently investigated with no overt use of AI noted. It is proposed that going forward the exams will be invigilated as happened in the pre-Covid times to mitigate the use of AI.

There was a good range of assessment methods, so that students are provided with a variety of ways to demonstrate their knowledge and are not reliant on a single method of assessment. This is in line with practice across the sector. It is noteworthy that the BVetMed course requires students to pass an "in person" examination (DOPS) that tests not only their animal handling abilities but also their ability, as future vets, to sum up a situation quickly and deal with it efficiently, calmly and professionally. Considerable weight is given to this particular examination as students must pass every individual component. Students are, however, given an opportunity to resit one or more specific components if necessary.
