<p>Master's degree graduates have in-depth and advanced knowledge and understanding of their subject and/or profession, informed by current practice, scholarship and research. This will include a critical awareness of current issues and developments in the subject and/or profession, critical skills, knowledge of professional responsibility, integrity and ethics and the ability to reflect on their own progress as a learner. Graduates of all types of master's degrees are equipped to enter a variety of types of employment (either subject-specific or generalist) or to continue academic study at a higher level, for example a doctorate (provided that they meet the necessary entry requirements). Graduates of professional/practice master's programmes in particular possess the skills and experience necessary for some professions or areas of practice. Graduates of specialist such as the MSc in Wild Animal Health are likely to be characterised in particular by their ability to complete a research project in the subject, which in some subjects includes a critical review of existing literature or other scholarly outputs. <p>Educational Philosophy - The modular structure of the Wild Animal Health (MSc WAH) is built around practical rotations and problem-based learning scenarios, which together encourage critical thinking, decision-making, exploration and inquiry, and awareness of current issues at the forefront of wild animal health and biology. Important systematic knowledge and insights into novel research are given in lectures to complement the problem-based approach, while additional practical skills are taught through visits to selected advanced institutions.</p>
