There is variation in cohorts performance over the years and there are some good and some poor students. This year cohort was larger than the year before with 2 part-time students.

Overall mark of the students was relatively similar to each other this year, with one distinction. However, within each band the performance of individual students remains appropriate. All students attaining a MSc are competent to appreciate underlying principles and apply methods to data, providing a good foundation.

Work presented evidences a high degree of engagement by students with the learning materials. Students appear to encounter difficulties with the LSHTM modelling module this year.
