3.4 Standard of marking

the standard of marking is on the whole very good, the standardisation of the feedback format across the modules is consistent and I particularly like the " even better if...." aspect of the feedback. There were some feedback comments which were too vague to help the student next time, for example, "pico question could use some work" and "you have not drawn from enough sources" as a student receiving that feedback I would not know what I had to do to improve my pico question , or how many sources is enough. In addition there was not clarity regarding when writing was to be in the third person and when it should be in the first person nor if there was a penalty attached to that

I agree with these comments. I would like to add that markers are usually specific and detailed in their feedback comments. I picked up some incorrect grading of references as 'N/A' when they clearly were applicable, so would advise markers to be careful when completing the marking grids.

Course Director Response:

Thank you for your observations and for providing us with clear examples of what you think is working well and what further enhancements you think we could make. We have noted the point about vague feedback comments and will remind markers to ensure their comments in the OCM / turnitin area are more specific and clear about what could be improved upon.

We will also provide explicit instructions for every written assignment activity in Learn regarding whether or not we would like learners to write an assignment in the first or third person and we will provide links to additional resources to help them understand the difference between both types and be in a better position to adopt an appropriate style in their academic writing.

Thank you for pointing out the use of N/A in the online OCM marking rubric. The Course Team have investigated and found this to be partly as a result of the way that the marking rubric is formatted in the OCM online marking tool and marker error. We will remind the marking team to ensure the appropriate box is ticked for referencing rather than inadvertent ticking of the N/A option.

- 1) Remind assessors that feedback comments should be clear, specific and written in a way that helps learners identify what could be done better.
- 2) Provide explicit instructions with additional links to resources about writing in the 1st and/or 3rd person in their academic writing for each and every written assignment activity on the course.
- Remind the marking team to ensure the appropriate box is ticked in the online OCM submission area for referencing (rather than inadvertently ticking the N/A option).
