5.	Form of Examination There are normally three forms of examination; written examinations, assignments and practical examinations. 5.1. Anaesthesia & Emergency Critical Care Paper 1: up to 2 hour paper containing MCQ's and Short Answer Questions Assignment 1: Patient Care Report 5.2. Diagnostic Techniques Paper 2: up to 2 hour paper containing MCQ's and Short Answer Questions 5.3 Professional Development & Clinical Skills (II) OSPVE: 12 stations covering a range of clinical skills from Year 1 RCVS Nursing Progress Log: continuous assessment of practical skills in practice Reflective Component: BLOGS relevant to Year 2 [Practical skills will be assessed via the RCVS electronic Nursing Progress Log continuously throughout the course and must be completed by the end of Year 3 of the course].
6.	Marking Criteria 6.1. Assignments: RVC Common Grading Scheme. 6.2. Multiple Choice Questions: The pass mark for the MCQ examinations as a whole will be set according to approved and accepted standard setting protocols, normalised and then scaled. The number of marks available for each type of question will be clearly stated on the examination paper. A question left unanswered or deleted by the candidate will score zero. 6.3. Short Answer Questions Short Answer Questions are marked against the College's 0-10 marking scheme. 6.4. OSPVEs A pass mark will be set for each station. The pass mark for the examination as a whole will be set according to approved and accepted standard setting protocols, including if appropriate a minimum number of stations to be passed, then normalised and scaled. 6.5 Reflective component (BLOGS) The BLOGS must be satisfactorily completed in accordance with the guidelines and will be graded as pass or fail.

8.	Requirements to Pass Overall			
8.1	Year 2 of the FDSc Veterinary Nursing			
8.1.1	Modules In order to pass a module a student must obtain an aggregated average of 50% from the assessment activities combined.			
8.1.2	FDSc Year 2 To have achieved a pass in all modules AND To have achieved a pass in the practical examinations (OSPVE's) AND To have achieved a pass in the Reflective BLOG activity.			
9.	Requirements to Proceed			
	To Proceed to Year 3 of the FDSc Veterinary Nursing To have met the requirements to pass Year 2 of the FDSc overall (section 8.1.2).			
10.	Consequences of Failure or Failure to Complete			
10.1	A student is required to resit any module failed at the first attempt. In order to resit a student will retake any assessment activity failed at the first attempt.			
10.2	The mark obtained for a module at the second attempt shall be no greater than 50%.			
10.3	A student who has failed the year at the second attempt and has not previously repeated a year of study will be entitled to repeat the year. The number of attempts at assessments will be the same as for those students not repeating the year. All modules taken under the 'repeat year' rule will be capped at a maximum of a bare pass.			
10.4	A student who has failed the year at the second attempt and has previously repeated a year of study will be required to withdraw from the course. S/he will have a right of appeal as described in College Regulations.			
10.5	A student who successfully completed Year 1 remains eligible for the award of Certificate in Higher Education in Small Animal Welfare & Care.

11.	Award and Classification Year 2 of the FDS _c contributes 50% towards the overall FDS _c final mark. Average mark of 50 - 64% obtained from year 2 and 3 combined: Pass Average mark of 65 - 74% obtained from year 2 and 3 combined: Merit Average mark of 75% or more obtained from year 2 and 3 combined: Distinction
12.	Disclosure of Marks Results will be published by candidate number.
13.	Absence from Summative Assessment Where a student has an <i>allowable</i> absence, s/he will be marked absent (A) from a summative assessment and will be required to sit the assessment activity at the next available opportunity. An allowable absence is one that is for a significant unforeseeable event such as illness. Any other foreseeable absence will only be considered allowable if agreed by the Academic Progress Committee and this will only apply in very strictly limited circumstances. A student absent for any other reason will be awarded 0 (zero) for the assessment.
