1.	<b>Course</b> Foundation Degree in Science in Veterinary Nursing
2.	<b>Year</b> 3
3.	<b>Applicable to Academic Year</b> 2014/15
4.	<b>Aspects of Course Covered by Examination</b>  All modules studied in Year 3
5.	<b>Form of Examination</b>  There are normally three forms of examination; written examinations, assignments and practical examinations.
5.1.	<b>Applied Nursing Care</b> <b>Paper 1:</b> up to 2 hour paper containing MCQ's and Short Answer Questions <b>Assignment 1:</b> Essay
5.2.	<b>Professional Practice</b> <b>Paper 2:</b> up to 1 hour written paper <b>Assignment 2:</b> Literature Review
5.3.	<b>Professional Development &amp; Clinical Skills (III)</b> <b>OSPVE:</b> 12 stations covering a range of clinical skills from Year 2 & 3 <b>RCVS Nursing Progress Log:</b> Completion of RCVS NPL <b>Reflective Component:</b> BLOGS relevant to Year 3
5.4.	<b>Optional Assessment for top up to BSc Year 4</b> <b>Report:</b> at least 2000 words on methods of infection control in the practice <b>Extended Essay:</b> at least 2000 words on an aspect of Professional Development <b>Written Exam:</b> up to 1 hour written paper  <b>[Practical skills will be assessed via the RCVS electronic Nursing Progress Log continuously throughout the course and must be completed by the end of Year 3 of the course].</b>
6.	<b>Marking Criteria</b>
6.1.	<b>Assignments:</b> RVC Common Grading Scheme.
6.2.	<b>Multiple Choice Questions:</b> The pass mark for the MCQ examinations as a whole will be set according to approved and accepted standard setting protocols, normalised and then scaled. The number of marks available for each type of question will be clearly stated on the examination paper. A question left unanswered or deleted by the candidate will score zero.
6.3.	<b>Short Answer Questions</b> Short Answer Questions are marked against the College's 0-10 marking scheme.
6.4.	<b>OSPVEs</b> A pass mark will be set for each station. The pass mark for the examination as a whole will be set according to approved and accepted standard setting protocols, including if appropriate a minimum number of stations to be passed, then normalised and scaled.

8.1.1	<b>Modules</b> In order to pass a module a student must obtain an aggregated average of 50% from the assessment activities combined.			
8.1.2	<b>FDSc Year 3</b> To have achieved a pass in all modules AND To have achieved a pass in the practical examinations (OSPVE's) AND To have achieved a pass in the Reflective BLOG activity AND To have completed the RCVS Nursing Progress Log AND To have completed the placement hours (2100 hours over 60 weeks) required for entry to the RCVS List of Veterinary Nurses			
9.	<b>Requirements to Proceed (BSc Top Up)</b>  <b>To Proceed to Year 4 of the BSc Veterinary Nursing</b> To have achieved an aggregate average of at least 50% from the 3 Top Up assessments (section 7.4). AND To have met the requirements to be awarded the FDSc as described in section 8.			
10.	<b>Consequences of Failure or Failure to Complete</b>			
10.1	A student is required to resit any module failed at the first attempt. In order to resit a student will retake any assessment activity failed at the first attempt.			
10.2	The mark obtained for a module at the second attempt shall be no greater than 50%.
