| 5. | <b>Form of Examination</b><br><br>There are normally three forms of examination; written examinations, assignments and practical examinations.<br><br>5.1. <b>Applied Nursing Care</b><br><b>Paper 1:</b> up to 2 hour paper containing MCQ's and Short Answer Questions<br><b>Assignment 1:</b> Essay<br><br>5.2. <b>Professional Practice</b><br><b>Paper 2:</b> up to 1 hour written paper<br><b>Paper 3:</b> up to 1 hour written paper<br><b>Assignment 2:</b> Literature Review<br><br>5.3 <b>Professional Development &amp; Clinical Skills (III)</b><br><b>OSPVE:</b> 12 stations covering a range of clinical skills from Year 2 & 3<br><b>RCVS Nursing Progress Log:</b> Completion of RCVS NPL<br><b>Reflective Component:</b> BLOGS relevant to Year 3<br><br>[Practical skills will be assessed via the RCVS electronic Nursing Progress Log continuously throughout the course and must be completed by the end of Year 3 of the course].  |
| 6. | <b>Marking Criteria</b><br><br>6.1. <b>Assignments:</b><br>RVC Common Grading Scheme.<br><br>6.2. <b>Multiple Choice Questions:</b><br>The pass mark for the MCQ examinations as a whole will be set according to approved and accepted standard setting protocols, normalised and then scaled. The number of marks available for each type of question will be clearly stated on the examination paper. A question left unanswered or deleted by the candidate will score zero.<br><br>6.3. <b>Short Answer Questions</b><br>Short Answer Questions are marked against the College's 0-10 marking scheme.<br><br>6.4. <b>OSPVEs</b><br>A pass mark will be set for each station. The pass mark for the examination as a whole will be set according to approved and accepted standard setting protocols, including if appropriate a minimum number of stations to be passed, then normalised and scaled.<br><br>6.5 <b>Reflective component (BLOGS)</b><br>The BLOGS must be satisfactorily completed in accordance with the guidelines and will be graded as pass or fail. |

| 10.4       | A candidate who is unable to proceed to Year 4 of the BSc after resit has a right of appeal as described in the College Regulations even if s/he meets the requirements to proceed to FdSc.  |
| 10.5       | A candidate who has successfully completed Year 1 and Year 2 with not less than 40% in each module remains eligible for the award of Certificate in Higher Education in Small Animal Welfare & Care.   |
| <b>11.</b> | <b>Award and Classification</b><br><br>Year 3 will contribute 17.5% to the overall BSc degree classification.  |
| <b>12.</b> | <b>Disclosure of Marks</b><br><br>Results will be published by candidate number.   |
| <b>13.</b> | <b>Absence from Summative Assessment</b><br><br>Where a student has an <i>allowable</i> absence, s/he will be marked absent (A) from a summative assessment and will be required to sit the assessment activity at the next available opportunity.<br><br>An allowable absence is one that is for a significant unforeseeable event such as illness. Any other foreseeable absence will only be considered allowable if agreed by the Academic Progress Committee and this will only apply in very strictly limited circumstances.<br><br>A student absent for any other reason will be awarded 0 (zero) for the assessment. |
| <b>14.</b> | <b>Late Submission of Work</b><br><br>Reports, Projects and Assignments submitted after the due deadline will be subject to the late submission policy set out in the College's General Assessment Regulations.  |
