9.1.	In order to gain the Certificate in Work-based Learning and Research: An average mark of 40% or above must be gained from the marks listed in 8.1 above.

10.	<p>Consequence of Failure:</p> <p>10.1. A candidate who fails to complete a 30 weeks full-time placement in a workplace(s) relevant to their course will be allowed to either:</p> <p style="padding-left: 40px;">Defer their subsequent studies for a year to complete their 30 weeks full-time in placement</p> <p style="padding-left: 40px;">OR</p> <p style="padding-left: 40px;">Complete the required 30 weeks full-time at a later date, for example during holidays or after completing the subsequent year</p> <p style="padding-left: 40px;">OR</p> <p style="padding-left: 40px;">Exit the placement year scheme and restart studies at the start of the subsequent year</p> <p>10.2. A candidate who fails the placement year summative assessment shall be given the opportunity to resubmit. The candidate will be required to resubmit their Project Report and a new supervisor's assessment mark will be given.</p> <p style="padding-left: 40px;">The overall average mark obtained at the second attempt shall be no greater than 40%.</p> <p>10.3. If the candidate has not completed their Reflective Oral Presentation, s/he can resit the Reflective Oral Presentation on one further occasion.</p> <p>10.4. A candidate who fails after a second attempt will be required to withdraw from the course. S/he has a right of appeal as described in the College Regulations.</p>
11.	<p>Classification and Awards:</p> <p>11.1. A Merit is awarded for an average mark of 60-69%.</p> <p>11.2. A Distinction is awarded for an average mark of 70% and above.</p>
12.	<p>Disclosure of Marks:</p> <p>Results will be published by candidate number</p>
13.	<p>Absence and Summative in-course assessment:</p> <p>Where a student has an <i>allowable</i> absence, s/he will be marked absent (A) and will be required to undertake the assessment as a resit.</p> <p>An allowable absence is one that is for a significant unforeseeable event such as illness.</p> <p>Any other foreseeable absence will only be considered allowable if agreed by Academic Progress Committee and this will only apply in very strictly limited circumstances.</p> <p>A student absent for any other reason will be awarded 0 (zero) for the assessment.</p>
