10.	Consequences of Failure		
10.1.	Progress Assessment A student who fails to receive a recommendation to continue as a result of a progress assessment will be considered to be 'on probation' for a period of not less than one month and not greater than three months until progress is reviewed at a follow-up assessment. The student will normally be referred to PG Academic Progress Committee (APC) at this stage. If satisfactory progress has not been achieved by the 3 month follow-up, the student will be will be required to relinquish the course.
