Consequences of Failure
A student who fails a module at the first attempt shall have a right to resit. S/he will be required to resit those pieces of work that were failed (with less than 40%) at the next available opportunity.
Where the student has not yet completed all of the modules in a Stage, s/he will be <b>required to resit</b> any piece of work with a mark of 30-39% in order to pass a module if it has not been passed on aggregate at the first attempt.
The module mark obtained at the second attempt will be no greater than 40%.
When a module resit involves a piece of assessed work, the amount of time the resit student is given to do that work should be the same as on the first occasion.
A student who fails at the second attempt will be required to relinquish the course. S/he will have a right of appeal as described in College Regulations
Classification & Awards
From the combined mark taken from all of the components defined above, a candidate who achieves:
70% or more at the first attempt from the aggregate of all modules: 60-69% at the first attempt from the aggregate of all modules: 40-59% at the first attempt from the aggregate of all modules: Pass
Disclosure of Marks
Results will be published by candidate number.
Absence From In-Course Assessment
An allowable absence is one that is for a significant unforeseeable event such as illness. Any other foreseeable absence will only be considered allowable if agreed by Student Support and Progress systems and this will only apply in very strictly limited circumstances.
A student absent for any other reason will be awarded 0 (zero) for the assessment.
Late Submission of Work
Reports, Projects and Assignments submitted after the due deadline will be subject to the late submission policy set out in the College's General Assessment Regulations. Major pieces of work are specified in the Part 3 Assessment Weighting document and will be reduced to a maximum of a bare pass (40%) within the late submission window.
