4.	<p><b>Aspects of Course Covered by Examination</b></p> <p>All modules studied in Year 3</p>
5.	<p><b>Form of Examination</b></p> <p>There are normally three forms of examination; written examinations, assignments and practical examinations.</p> <p>5.1. <b>Applied Nursing Care</b>  <b>Paper 1:</b> up to 2-hour paper containing MCQs and Short Answer Questions  <b>Assignment 1:</b> Essay</p> <p>5.2. <b>Professional Practice</b>  <b>Paper 2:</b> up to 1 hour written paper containing Short Answer Questions  <b>Assignment 2:</b> Assignment</p> <p>5.3. <b>Professional Development &amp; Clinical Skills (III)</b>  <b>Objective Structured Clinical Examinations (OSCE):</b> 12 stations covering a range of RCVS day one skills clinical skills from Year 2 &amp; 3  <b>Completion of the RCVS Day one skills and competencies (via Nursing Progress Log)</b>  <b>Reflective Component:</b> Discussion forum activity relevant to Year 3</p> <p>5.4. <b>Optional Assessment for Transfer to BSc Year 4</b>  <b>Report:</b> at least 2000 words on methods of infection control in the practice  <b>Extended Essay:</b> at least 2000 words on an aspect of Professional Development  <b>Written Exam:</b> up to 1 hour written paper containing Short Answer Questions</p> <p>[RCVS Day one skills and competencies for veterinary nurses will be assessed continuously throughout the course via an approved electronic student experience log (currently the Nursing Progress Log), which must be completed by the end of year 3 of the course].</p>
6.	<p><b>Marking Criteria</b></p> <p>6.1. <b>Assignments:</b>  The appropriate College Common Grading Scheme will be used for marking extended pieces of work depending on the type of assessment. The Common Grading Schemes available are:</p> <ul style="list-style-type: none"> <li>• Common Grading Scheme (LAQ)</li> <li>• Common Grading Scheme (CPRQ – Undergraduates)</li> <li>• Common Grading Scheme (Reflective Writing)</li> </ul> <p>6.2. <b>Multiple Choice Questions:</b>  The pass mark for the MCQ examinations as a whole will be set according to approved and accepted standard setting protocols, normalised and then scaled. The number of marks available for each type of question will be clearly stated on the examination paper. A question left unanswered or deleted by the student will score zero.</p>

6.4.	<p><b>Objective Structured Clinical Examinations (OSCEs)</b> A pass mark will be set for each station. The pass mark for the examination as a whole will be set according to approved and accepted standard setting protocols, including if appropriate a minimum number of stations to be passed, then normalised and scaled.</p>			
6.5	<p><b>Reflective Component (Discussion Forum)</b> The discussion forum activity must be satisfactorily completed in accordance with the guidelines and will be graded as pass or fail.</p>

8.1.2.	<p><b>FdSc Year 3</b> To have achieved a pass in all modules AND To have achieved a pass in the practical examinations (OSCEs) AND To have achieved a pass in the Reflective Discussion Forum activity AND To have completed the RCVS Day one skills &amp; competencies AND To have completed the 1800 placement hours</p>

<b>9.</b>	<p><b>Requirements to Proceed (BSc Transfer)</b></p> <p><b>To Proceed to Year 4 of the BSc Veterinary Nursing</b>          To have achieved an aggregate average of at least 50% from the 3 Transfer assessments (section 5.4).</p> <p>AND          To have met the requirements to be awarded the FdSc as described in section 8.</p> <p>OR          To have gained a merit overall in the FdSc award</p>						
<b>10.</b>	<p><b>Consequences of Failure, Failure to Complete</b></p> <p>10.1. A student is required to resit any module (leading to the Foundation degree), failed at the first attempt. In order to resit a student will retake any assessment activity failed at the first attempt.</p> <p>10.2. The mark obtained for a module at the second attempt shall be no greater than 50%.</p> <p>10.3. A student who fails to satisfy the requirements for the award of the FdSc VN (section 8.1) after two attempts is required to relinquish the course. They have a right of appeal as described in the College Regulations</p> <p>10.4. A student who successfully completed Year 1 remains eligible for the award of Certificate in Higher Education in Small Animal Welfare &amp; Care.</p>

<b>12.</b>	<p><b>Disclosure of Marks</b></p> <p>Results will be published by candidate number.</p>						
<b>13.</b>	<p><b>Absence from Summative Assessment</b></p> <p>Where a student has an <i>allowable</i> absence, they will be marked absent (A) from a summative assessment and will be required to sit the assessment activity at the next available opportunity.</p> <p>An allowable absence is one that is for a significant unforeseeable event such as illness. Any other foreseeable absence will only be considered allowable if agreed by the Student Performance and Development System and this will only apply in very strictly limited circumstances.</p> <p>A student absent for any other reason will be awarded 0 (zero) for the assessment.</p>
